## Universal Monsters Halloween Second-Chance Promotion AMENDED

# THE NMLA AT ITS SOLE DISCRETION MAY END OR CANCEL THIS PROMOTION AT ANY TIME. PROMOTION AND RULES ARE SUBJECT TO CHANGE AT THE NMLA'S DISCRETION AT ANY TIME.

#### 1. Promotion Description

- a. The New Mexico Lottery Authority (NMLA) will conduct the Universal Monsters Halloween Second-Chance Promotion (Promotion) according to these rules, the New Mexico Lottery Promo Zone Program Rules, and the Second-Chance and Promotional Drawing Rules.
- b. Seven (7) drawings will be conducted to award:
  - i. Thirty (30) prizes of one thousand dollars (\$1,000) and
  - ii. One (1) prize of ten thousand dollars (\$10,000) (Grand Prize Drawing).

#### 2. Entry Periods, Deadlines, and Drawing Dates

- a. Entries must be received no later than 11:59:59 PM MT on the Entry Deadline Dates listed in the Entry and Draw Schedule below.
- b. An entry submitted between an Entry Start Date and an Entry Deadline Date is only eligible for the corresponding drawing and an entry does not carry forward as an entry in a subsequent drawing(s), except that all entries submitted during the Promotion are eligible for the Grand Prize Drawing (Draw 7). Drawings will be held after 10:00 AM MT on the dates below, or as soon as practical.
- c. The Grand Prize Entry Deadline Date and the Drawing Date will be posted on the entry website once determined. The Drawing will be held on the date posted, or as soon as practical.
- d. Entry eligibility will be determined by the time/date of successful submission into the entry website for the Promotion.

#### 3. Location of Drawing:

#### 4. Eligibility Requirements:

- a. Players must certify that they are at least eighteen (18) years of age.
- b. Players must enter through the Promo Zone program at nmlottery.com.
- c. Players that are not members of the Promo Zone program may join at nmlottery.com.
- d. Players must manually enter any eligible non-winning Scratcher ticket from Game # 566 Universal Monsters Halloween.
  - The twelve (12) digit ticket number is located on the back of the ticket above the barcode and the ten (10) digit entry number is located on the front of the ticket, underneath the scratch-off coating.
- e. Players may submit multiple tickets. However, each ticket may only be entered once.
- f. Players may enter up to fifty (50) tickets per day.
- g. Players may win only one (1) time in each drawing but can win in any of the seven (7) drawings.
- h. Entries mailed or hand-delivered to the NMLA will be disqualified and will not be returned.

#### 5. Prize Details

- a. Thirty (30) entries will be selected in the first six (6) drawings to win one thousand dollars (\$1,000).
- b. One (1) entry will be selected in the Grand Prize Drawing to win ten thousand dollars (\$10,000).

#### 6. Drawing Procedures

- a. An NMLA Security representative will conduct the seven (7) drawings, as indicated on the Entry and Draw Schedule using a random number generator.
- b. In the first six (6) drawings, five (5) entries will be selected for each drawing. Three (3) alternates will be selected for each drawing.
- c. In the Grand Prize Drawing, one (1) entry will be selected. Three (3) alternates will be selected.

#### 7. Selected Entry Notification

- a. The Procedures for Notification of Selected Entries of Second-Chance or Promotional Drawings will be followed.
- b. A selected entrant will be notified using the email address on file in the Promo Zone. In addition to the email, the NMLA may attempt to notify a selected entrant by phone.
- c. The selected entrant must acknowledge receipt of the email or phone call and/or submit the completed NMLA Claim Form within the timeframe specified by the NMLA. Failure to submit the completed NMLA Claim Form in the above designated timeframe may result in disqualification, in which case the first alternate will be contacted, and the same process will be followed.

#### 8. Miscellaneous

- a. Exceptions or modifications to these rules must be approved in writing by the NMLA CEO and the NMLA EVP for Security.
- b. The Grand Prize Drawing selected entrant is responsible for all federal and state taxes associated with the Grand Prize Drawing prize upon submitting the NMLA Claim Form.

- c. The Grand Prize Drawing winner will receive an IRS Form W-2G.
- d. The NMLA will withhold and deposit the minimum required federal tax withholdings and any applicable state tax withholdings on behalf of the Grand Prize Drawing winner.
- e. Failure to provide accurate information could cause a player selected as a drawing winner to be disqualified.
- f. Upon submitting an entry, the player(s) agree that the NMLA may use their name, voice, photograph, video, any social media postings, and/or likeness in any form for the purpose of advertising and/or publicizing the NMLA.
- g. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- h. Use or distribution of "auto" software programs or other similar software programs or applications to enter tickets or ticket codes into any drawing is prohibited. If discovered to be using such a program or application, a player's entries may be disqualified.
