
**SUBJECT:** Monthly Turnover of Revenues to the State of New Mexico

---

The amount of estimated revenues transferred for August 2024 (FY 2025) is \$3,721,532 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2025 proceeds total \$7,297,176 compared to \$10,639,829 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by September 30, 2024.
