## SUBJECT: Monthly Turnover of Revenues to the State of New Mexico

The amount of estimated revenues transferred for November 2024 (FY 2025) is \$3,544,442 (30.00%). The total amount will go to the Lottery Tuition Fund (Agency Code 950, Fund Code 637, Cash Account 29).

Year-to-date, the lottery has returned an average 30.00% in revenues. Fiscal Year 2025 proceeds total \$18,216,308 compared to \$22,727,641 (an average 30.00%) for the same period last year.

This money will be wired to the state treasury accounts by December 31, 2024.
